
I, Elizabeth J. Vrato, being duly sworn, depose and state:



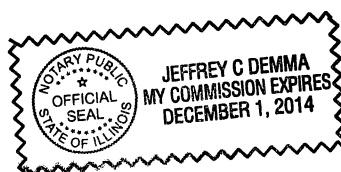
